1. **Dakshinkali Municipality** invites sealed bids or electronic bids from eligible bidders for the construction of **Chalnakhel-Bosan-Kirtipur sadak**, **Dakshinkali-01** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Work experience of similar size and nature: [at least one project of similar size and nature with value of Nrs 1,55,54,000.00/-]
- 2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.



Bidder who chooses to submit their bid electronically, Bidders are required to submit two separate bid response documents, one containing (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 21 of the Bidding Document.

- 3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Dakshinkali Municipality, Pharping, Kathmandu, Bagmati Province, Nepal or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
- 4. Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document i.e 5000/- in the account as specified below.

- 5. Pre-bid meeting shall be held at *Meeting hall of dakshinkali municipality* at 15-09-2025,13:00.
- 6. Sealed or electronic bids must be submitted to the office through PPMO's e-GP system www.bolpatra.gov.np/egp on or before [12:00] on [28-09-2025]. Bids received after this deadline will be rejected.
- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at [13:00, 28-09-2025] at the office of [Dakshinkali Municipality]. Bids must be valid for a period of [120 days] from the bid submission deadline and must be accompanied by a bid security or

- scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **7,50,000/-** which shall be valid for 30 days beyond the validity period of the bid (*i.e.* 28/02/2026])
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
