1. **The Dakshinkali Municipality has allocated funds towards the cost of *Krishna mandir-lakurebot bot hudei mul sadak jane sadak da.na.pa. 09*** and intends to apply part of the funds to cover eligible payments under the Contract **for DM/NCB/WORKS/2082/02**. Bidding is open to all eligible as per Section V of bidding document.
2. **The Dakshinkali Municipality** invites electronic bids from eligible bidders for the construction of **Upgrading of road** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years NRs 3,85,00,000/-Minimum Work experience of similar size and nature: at least One (1) Contract with a value of at least NRs 1,53,90,000/-
3. Bidder who chooses to submit their bid electronically, Bidders are required to submit two separate bid response documents, one containing (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 21 of the Bidding Document
 4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of **[Name, location, mailing address, telephone and facsimile numbers and email address of the Employer]** or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
 5. Bidder who chooses to submit their bid electronically may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document (Nrs 5000/-) in the account as specified below .

6. Pre-bid meeting shall be held at **Dakshinkali Municipality, pharping Kathmandu** at **15-09-2025 on time 13:00 PM**
7. Electronic bids must be submitted to the office through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12 PM** on 28-09-2025. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13 PM** on 28-09-2025 at the office of **Dakshinkali Municipality, Pharping Kathmandu**. Bids must be valid for a period of **120 days from** the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **750000** which shall be valid for 30 days beyond the validity period of the bid (**ie till 26-02-2026**)
9. If the last date of purchasing and /or submission falls on a government holiday, then the next

working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
