- 7. Electronic bids must be submitted to the office through PPMO's e-GP system <a href="https://www.bolpatra.gov.np/egp">www.bolpatra.gov.np/egp</a> on or before 12 PM on 28-09-2025. Bids received after this deadline will be rejected.
- 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13 PM on 28-09-2025 at the office of Dakshinkali Municipality, Pharping Kathmandu. Bids must be valid for a period of 120 days from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of 750000 which shall be valid for 30 days beyond the validity period of the bid (ie till 26-02-2026)
